## **1. Aims**

This policy aims to:

- Set out our approach to requiring a uniform that is of reasonable cost and offers the best value for money for parents and carers
- Explain how we will avoid discrimination in line with our legal duties under the Equality Act 2010
- Clarify our expectations for school uniform

## **2. Our school's legal duties under the Equality Act 2010**

The [Equality Act 2010](#) prohibits discrimination against an individual based on the protected characteristics, which include age, sex, disability, race, religion or belief, pregnancy and maternity, and gender reassignment.

To avoid discrimination, our school will:

- Avoid listing uniform items based on sex, to give all pupils the opportunity to wear the uniform they feel most comfortable in or that most reflects their self-identified gender
- Make sure that our uniform costs the same for all pupils
- Allow all pupils to have long hair (though we reserve the right to ask for this to be tied back)
- Allow all pupils to style their hair in a way that is appropriate for school and makes them feel most comfortable
- Allow pupils to request changes to swimwear for religious reasons or if they are experiencing discomfort related to their sex, gender or gender reassignment
- Allow pupils to wear headscarves and/or other religious garments
- Allow pupils with sensory or physical needs to make reasonable adaptations to their uniform depending on their specific needs
- Allow for reasonable adaptations to our policy on the grounds of equality by asking pupils or their parents/carers to get in touch with the school office, who can answer questions about the policy and respond to any requests. These will be considered on a case-by-case basis

## **3. Limiting the cost of school uniform**

Our school has a duty to make sure that the uniform we require is affordable, in line with statutory [guidance](#) from the Department for Education (DfE) on the cost of school uniform.

We understand that items with distinctive characteristics (such as branded items, or items that need to have a school logo or a unique fabric/colour/design) cannot be purchased from a wide range of retailers and that requiring many such items limits parents/carers' ability to 'shop around' for a low price.

We will make sure our uniform:

- Is available at a reasonable cost
- Provides the best value for money for parents/carers

We will do this by:

- Carefully considering whether any items with distinctive characteristics are necessary

- Limiting any items with distinctive characteristics where possible: for example, children can wear a jumper with a logo if that is parental choice
- Limiting items with distinctive characteristics to low-cost and/or long-lasting items, such as ties
- Considering cheaper alternatives to school-branded items, such as logos that can be ironed on, as long as this doesn't compromise quality and durability
- Avoiding specific requirements for items pupils could wear on non-school days, such as coats, bags and shoes
- Keeping the number of optional branded items to a minimum, so that the school's uniform can act as a social leveller
- Avoiding different uniform requirements for different year/class/house groups
- Avoiding different uniform requirements for extra-curricular activities
- Considering alternative methods for signalling differences in groups for interschool competitions, such as creating posters or labels
- Making sure that arrangements are in place for parents/carers to acquire second-hand uniform items
- Avoiding frequent changes to uniform specifications and minimising the financial impact on parents/carers of any changes
- Consulting with parents/carers and pupils on any proposed significant changes to the uniform policy and carefully considering any complaints about the policy

## **4. Expectations for school uniform**

### **4.1 Our school's uniform**

Our school uniform colour is a combination of grey and royal blue. Most items can be bought from High Street shops.

#### **Children's Uniform**

- Grey pinafore dress/skirt
- Long grey or black trousers
- Short grey or black trousers (Summer only)
- White shirt
- Royal blue and white striped tie (elasticated or tie your own)
- Royal blue knitted jumper or cardigan with or without school logo
- Black, white, navy or grey socks/tights
- Plain black shoes (no logos or sparkly bits), no high heels/wedges/platform shoes
- Hair bands/accessories should be navy, black, white or grey only
- Warm coat (Winter)
- Scarf, hat, gloves (Winter)
- Dress in royal blue gingham or stripes (Summer)
- Hat or baseball cap (essential sun protection)

Please note skirts should be an appropriate length and of a style which allows children to sit comfortably on the floor. If shorts are worn, even when these are worn over tights, they should also be of an appropriate length. Three-quarter and calf length trousers and leggings should not be worn.

Shoes should be flat, black and appropriate for school. If trainers are worn these should be plain without logos. Your child should wear shoes which he or she can manage to do up independently. Please do not send your child to school in shoes which prevent them from running in the playground.

### **PE Kit**

Children need a change of clothes and footwear for PE (for health and hygiene reasons) and a draw-string bag in which to keep the kit at school. All school uniform and PE kit **MUST** be named. Children can become upset as a result of lost clothing, please help us by naming everything.

### **Children's PE Kit**

- Plain black shorts (no logos or markings)
- Plain black plimsolls
- Tracksuit in a dark colour with no logos for outdoor PE in winter
- Plain black trainers for outdoor PE (no logos or markings)
- Plain white t-shirt (no logos)

For health and safety reasons children are not permitted to wear earrings for PE. Your child's teacher will advise you when PE lessons take place so that earrings can be removed.

If children contravene the school uniform policy, they will be unable to go onto the playground for break and lunchtimes. Parents will be contacted and asked to resolve the uniform issues as soon as possible.

### **Nursery**

There is more flexibility with the nursery uniform, but the items should be the same colour as the school uniform colours.

### **Jewellery, Hair Ornaments, Make-up and Nail Varnish**

For health and safety reasons we do not allow children to wear jewellery. The exceptions to this rule are earring studs in pierced ears (lobes only) and small objects of religious significance. No other form of body piercing is acceptable. Children are required to remove any items during PE lessons to prevent them from causing injury. Children with newly pierced ears will not be able to participate in physical activities until they are able to remove the earrings. Please note: Teachers are not permitted to remove earrings. Hair bands, ribbons / bows or 'scrunchies' should be in school colours. Hair bands should not have large flowers attached. Make-up and nail varnish should not be worn to school unless for an out of school hours function, for example a school disco. Hairstyles and haircuts – parents are asked to use their discretion when deciding hair styles/cuts for their children and what is appropriate for school. Hairstyles with words, patterns, symbols or shapes cut

into them will still be considered extreme haircuts and will not be permitted. Long hair should be tied back for designated activities.

### **Footwear**

For health and safety reasons we do not allow children to wear shoes with platform soles, high heels, or backless shoes, such as sandals or flip flops. All children are required to wear plain black shoes or trainers without logos as stated in the uniform list. If boots are worn these should also be plain black. If boots are large and prevent children from sitting comfortably on the floor they may be asked to change into their PE shoes whilst inside the building.

### **4.2 Where to purchase it**

- Parents can obtain out tie from Personalise, Crittal Road in Witham. Other imtes with the logo including jumpers and backpacks can be purchased from here, however, they are not required uniform or equipment. Royal blue jumpers, shirts, skirts, trousers and pinafore can be purchased more widely from high-street retailers.
- The School Office has some uniform for sales. Please call office for more details.

## **5. Expectations for our school community**

### **5.1 Pupils**

Pupils are expected to wear the correct uniform at all times (other than specified non-school uniform days) while:

- On the school premises
- Travelling to and from school
- At out-of-school events or on trips that are organised by the school, or where they are representing the school (if required)

Pupils are also expected to contact Mr Sheehan or Mrs Harrington, Co-Headteachers, if they want to request an amendment to the uniform policy in relation to their protected characteristics.

### **5.2 Parents and carers**

We believe that one of the responsibilities of parents is to ensure that their child has the correct uniform and PE kit, and that it is clean, in good repair and that the child's name is written on all items. If a parent has difficulties for any reason with fulfilling this request they are asked to speak confidentially to a senior member of staff to discuss the issues. Parents should be assured that we do all we can to help. Children who arrive at school wearing non-school uniform clothing will be loaned an appropriate item from a stock of donated clean uniform to wear for that day. For children who do not have a PE kit in school, the teacher will ring the parent to see if the PE kit can be brought into school in time for the lesson. The school welcomes children from all backgrounds and faith communities. If there are serious reasons, for example on religious grounds, why parents want their child to wear clothes that differ from the school uniform, the school will consider such requests

sympathetically. If any parent would like to request a modification to the uniform policy they should, in the first instance, contact the Co-Headteachers.

Disputes about the cost of the school uniform will be:

- Resolved locally
- Dealt with in accordance with our school's complaints policy

The school will work closely with parents/carers to arrive at a mutually acceptable outcome.

### **5.3 Staff**

Staff will closely monitor pupils to make sure they are in correct uniform. They will give any pupils and families breaching the uniform policy the opportunity to comply, but will follow up with the headteacher if the situation doesn't improve.

Ongoing breaches of our uniform policy will be dealt with by the Co-Headteachers.

In cases where it is suspected that financial hardship has resulted in a pupil not complying with this uniform policy, staff will take a mindful and considerate approach to resolving the situation.

### **5.4 Governors**

The Trustees of Inspires MAT supports the Co-Headteachers in implementing the school uniform policy. It considers all representations from parents regarding the uniform policy and liaises with the Co-Headteachers to ensure that the policy is implemented fairly and with sensitivity. It is the Trustees' responsibility to ensure that the school uniform policy meets all regulations concerning equal opportunities. Trustees ensure that the school uniform policy enables children to dress sensibly, in clothing that is hardwearing, safe and practical.

## **6. Monitoring arrangements**

The Trustees monitor and review the school uniform policy through its committee work by:

- seeking the views of parents, to ensure that they agree with, and support the policy, through the Home School Agreement which parents are asked to sign when children join our school and which is reviewed regularly;
- considering, with the Co-Headteacher, any requests from parents for individual children to have specific dispensation with regard to school uniform.
- This policy will be reviewed every two years by the CEO of the Trust. At every review, the overarching policy will be approved by the Board of Trustees. It will then be issued to schools for personalisation and approval by local Governing bodies.
